**Insurance** All vendors with hazardous activities as determined by Strawberry Days Committee including but not limited to, wall climbing and rebound devices, shall provide a certificate of liability insurance (\$1,000,000 per occurrence /\$2,500,000 aggregate) that names Pleasant Grove City and Strawberry Days Association as an additional insured.

**Application** Please have your application submitted no later than May 10<sup>th</sup> 2018.

To help insure an equal opportunity for all vendors and our other contracts all applications will be juried. You will receive an email of acceptance, denial or notice that you have been placed on a cancellation/waiting list by May 20<sup>th</sup> 2018. Booth Spaces will not be assigned until payment is made in full. All fees are due no later than May 30<sup>th</sup>. Any fees not received by that date will constitute forfeiture of the vendor's booth space.

Please submit two or three photos of items to be sold and wherever possible a photo of your booth at a venue in which you have previously participated.

## Guidelines

1. This is an exciting and wonderful event. Please remember that this event is for all age groups and there will be absolutely no selling of items dealing with obscenities, illegal drug related material or any similar items of such nature as determined and juried by the committee.
2. All vendors agree and accept that Strawberry Days Association maintains right of sole and final say to prohibit, without any right of recourse by the offending vendor, the sale or promotion of any item or event which the Board deems, in its sole discretion, to violate the standards or Strawberry Days Committee. There will be nothing accepted that is in direct competition with the carnival.
3. All displays must conform to the general atmosphere of Strawberry Days.
4. Vendors are responsible for supply of their own canopies or coverings and extension cords.
5. Food vendors can not compete with anything sold at the carnival. And must purchase a temporary food permit from the Utah County Health Department: 151 South University Ave., Provo, Ut 801-851-7000.
6. Not all vendor spaces have available electricity. Electricity will be given on a first come – first served basis.
7. Vendors may not drive vehicles onto lawn or landscape for loading or unloading purposes. Plan accordingly.
8. Vendors who vend from a trailer **will not** be allowed.
9. Vendors are required to dispose of all their own trash in the large roll off dumpster provided. Vendors who leave trash, may be fined up to \$100 and or asked to vacate the boutique.
10. Vendors will not leave their vehicles parked on the street or in the parking stalls after unloading. Vehicles left parked here during operating hours may be towed.
11. All vendor items, including canopies, goods, vehicles, trailers, etc. must be cleaned from the area by June 23<sup>rd</sup> 2:30pm. We will be turning on the sprinklers to recover the landscape.
12. Food Vendors must make all necessary measures to ensure that oils, grease, hot coals do not damage the landscape and must be disposed of properly.
13. Strawberry Days Association will not provide any security for vendor booths. Any items left unattended are at the risk of the vendor.
14. Any Vendor claiming non-profit will be required to provide proof of 501C3 or similar proof of non profit status.

## Strawberry Days 2018 Vendor Agreement

The undersigned represents to Strawberry Days Association that he/she is fully authorized to sign for and bind the below named business (hereinafter referred to as "Vendor") regarding the Vendor's application and entry in the 2018 Strawberry Days Event. Vendor agrees that Vendor and all persons associated with Vendor shall comply with the rules, policies and procedures prescribed by Strawberry Days Association, as Strawberry Days Association deems necessary for the efficient safe and non-offensive conduct of the Strawberry Days Event and related activities. In addition, Vendor acknowledges and agrees to the following:

- Vendor has read and shall abide by all of the terms, conditions and guidelines in the 2018 Strawberry Days Vendor Application and shall abide by all local, state and federal laws and regulations, including, but not limited to, all business license requirements and food handlers' permits.
- Strawberry Days Association is only providing a space for Vendor to do business.
- Vendor agrees that Vendor will not receive any application fee refund for any reason, including but not limited to, inclement weather.
- Vendor shall be adequately insured and provide a certificate of insurance if requested by the City. If Vendor has a hazardous activity as determined by the Association, Vendor shall provide a certificate of liability insurance as required by Strawberry Days Association that names the Association and Pleasant Grove City as an additional insured.
- As a condition of being a vendor for the Strawberry Days Association, Vendor shall assume full responsibility for Vendor's conduct, which includes the conduct of all employees, sub contractors, supplies, guests and customers of Vendor, and for Vendor's content and presentation of it's activities, and to indemnify, defend and hold harmless Strawberry Days Association its officers, volunteers, Pleasant Grove city, it's employees and agents from and against any and all liabilities, claims, damages, losses and expenses, including, but not limited to, attorney's fees, incurred or suffered by Strawberry Days Association its officers, volunteers, Pleasant Grove city, it's employees and agents that is caused by or arises from (a) any negligent act or omission by Vendor or any person associated with Vendor or Vendor's entry, (b) any breach of Vendor's representations, warranties, or obligations herein, (c) any damage caused by or associated with Vendor or Vendor's entry, equipment, booth or area (d) any claim or lawsuit by any of Vendor's employees, subcontractors, suppliers, guests, customers, or third parties, or (e) any infringement or violation by Vendor or Vendor's associates of the rights of others.
